Child Concerns Information for children, parents & staff



Vision

Our vision is for a harmonious and inclusive community where the rights of all are held in high regard; where Gospel values are held at the heart of our mission. We aim to develop the selfesteem, dignity and respect of all members of the community. We promote a culture of high achievement and inspire our global citizens to live in our global village. Our aim is for everyone to feel welcome and to know that we will work in partnership to ensure that all learners grow and develop educationally, socially, emotionally and spiritually.

RATIONALE

Protecting children and young people is everyone's job and everyone's responsibility.

All children and young people have the right to be cared for; protected from harm and abuse; and grow up in a safe environment where their rights are respected and needs are met.

We all have the responsibility to keep children safe.

Matters for concern

Children don't always tell if they are being harmed. Sometimes, parents, staff or children see or hear things which make them worry about a child's care, welfare or safety. This may be related to the actions of anyone caring for a child.

It is not an option to do nothing or to assume that someone else will pass on the information. **Concerns must be reported.**

All information will be taken seriously and will be acted upon. Enquiries will be made with people from other agencies who may know the child well. This can include health visitors, teachers, social workers or the Family Protection Unit.

What happens next?

Once enquiries have been made, one or more of the following actions may be taken:

- The concern is recorded, but no further action is taken at this time
- Support or advice offered to the family
- o A formal Child Protection investigation jointly with the Family Protection Unit

SAFE, SECURE, PROTECTED

CHILDREN

Sometimes adults or other people hurt children and make them feel bad and afraid. That is not okay. Nobody should hurt you. Adults should never hurt children. Other children should never hurt you.

The most important thing to remember is that you have done nothing wrong, and it is never wrong to talk to someone and ask for help.

STAFF

- o act in full accordance with the Perth & Kinross Child Protection Procedures (2008)
